### **2025-34 CAPACITY PLANNING REPORTS TO CALRECYCLE**

#### **INTRODUCTION AND BACKGROUND**

Attached for Board review and discussion is the 2025-34 Capacity Planning Reports as submitted to CalRecycle on August 1, 2024. Senate Bill (SB) 1383, California’s Short-Lived Climate Pollutant Reduction Strategy law, requires each County in the state to submit a capacity plan for both organic waste processing and edible food recovery.

#### ***Organic Waste Capacity***

SB 1383 requires jurisdictions to implement mandatory organic waste collection and recycling in a statewide effort to divert organic waste from landfills. California has dozens of compost, mulch, and anaerobic digestion facilities located throughout the state that can recycle yard and food waste into new products. Recology Yuba Sutter takes organic waste collected in the RWMA region to its Ostrom Organics facility in Wheatland.

#### ***Edible Food Recovery Capacity***

SB 1383 requires that by 2025 the state must recover for people to eat 20 percent of still safe food that would have gone to landfills. This is a statewide goal that California must collectively achieve. Each county must plan for adequate capacity for edible food recovery. Counties in coordination with jurisdictions and regional agencies located within the county must actively expand and create new infrastructure to grow food recovery networks if additional capacity is needed.

Regulations require food recovery capacity planning to at least:

- Estimate the amount of edible food that mandated food donors in the county would send to landfills.
- Identify available existing capacity at food recovery organizations and services that could take the surplus food from food donors in the county.
- Identify whether new or expanded capacity is needed to recover edible food disposed by commercial edible food generators within the jurisdictions within the county.

Most edible food safe for human consumption that would otherwise have gone to the landfill is being recovered by Yuba Sutter Food Bank.

#### **2025-34 REPORTED CAPACITY**

The following tables summarize the current capacity available to the RWMA member agencies for organic waste processing and edible food recovery. Based on the capacity plans submitted to CalRecycle, the member agencies currently have sufficient capacity to process organic waste generated in the counties of Sutter and Yuba at Ostrom

Organics. The reports also show that there is sufficient capacity to collect edible food at currently disposed by the member agencies' mandated food donors.

### **2023 ELECTRONIC ANNUAL REPORT TO CALRECYCLE**

#### **INTRODUCTION AND BACKGROUND**

Attached for Board review and discussion is the 2023 Annual Report as submitted to CalRecycle on August 1, 2024. This report addresses the region's compliance status relative to:

- The California Integrated Waste Management Act of 1989 (AB 939) diversion goal of 50 percent by the year 2000
- The compliance status relative to the Mandatory Commercial Recycling (AB341), Mandatory Commercial Organics Recycling (AB 1826), and California's Short-Lived Climate Pollutant Reduction Strategy (SB 1383) Laws
- The implementation status of Source Reduction and Recycling Element (SRRE) and Household Hazardous Waste Element (HHWE) programs, and related Siting Element and Summary Plan issues.

With the passage of SB 1016 (2008), compliance with the 50 percent diversion requirement is now based on a per capita disposal figure comparison beginning with the 2007 Annual Report with the focus now on whether diversion programs have been implemented and maintained. This methodology establishes a baseline target per capita disposal figure for every jurisdiction or regional agency that is equivalent to the 50 percent diversion requirement using the average of the base year waste generation amount (disposal + diversion) adjusted for changes in population, taxable sales, employment, and the CPI for the years 2003 through 2006. The baseline target per capita disposal figure remains fixed at this amount.

For the RWMA, the baseline target per capita disposal figure is based on the average of the adjusted waste generation figures for 2005 and 2006 because the RWMA completed a New Base Year Waste Generation Study for 2004. The baseline target per capita disposal figure for the RWMA has been set at 6.9 pounds/person/day or half of the calculated per capita generation figure for the region. The per capita disposal amount for each reporting year (e.g., 2020) is now compared to the 6.9 pounds/person/day baseline target to determine if it is less than (greater than 50 percent diversion) or greater than (less than 50 percent diversion) the target amount.

#### **2023 ANNUAL REPORT**

In 2023, 177,453 tons of waste was reported as disposed of from the six RWMA jurisdictions. The resulting per capita disposal amount was 5.4 pounds/person/day, well below the baseline target amount of 6.9 pounds/person/day. This figure is equivalent to a diversion rate of 61 percent [13.8 pounds generated (twice the target amount) – 5.4 pounds disposed = 8.4 pounds diverted or 61 percent of the 13.8 pound baseline waste generation amount].

As reflected in the 2023 Annual Report, the state is increasingly focused on compliance with the state's Mandatory Commercial Recycling (AB 341) and Mandatory Commercial Organics Recycling (AB 1826) laws, as well as California's Short-Lived Climate Pollutant Reduction Strategy (SB 1383).

The annual report details the progress on implementing these laws in the region, which includes:

- Identifying edible food generators and recovery organizations, along with documenting edible food recovery efforts
- Describing collection systems offered in each jurisdiction
- Quantifying and describing the types of education and outreach provided to generators related to organic waste and recycling collection
- Documenting water efficient landscape and CalGreen projects
- Documenting the number of waivers and exemptions issued to commercial customers from organic waste collection
- Documenting Route Reviews conducted
- Documenting number of accounts included in the Compliance Review (desk audit)
- Documenting procurement of recovered organic waste products (Zero Foodprint Contract, Compost, Mulch)

Based on our review of data provided in the annual report, RWMA staff have identified gaps in providing organic waste service to all residents and businesses; monitoring compliance through route reviews; and procuring recovered organic waste products.

### ***Providing Organic Waste Services to All Residents and Businesses***

RWMA staff and Recology have conducted on-site inspections, discussed regulatory requirements, and options to comply with AB 341 and SB 1383 with over 950 commercial and multi-family businesses over the last two year. In addition, mailings, bill inserts, and printed copies of education materials have been delivered to all commercial businesses and multi-family properties throughout the RWMA region.

## **Agenda Item IV. – B**

As next steps for customers with gaps in service, RWMA staff will follow up with all customers that do not have a waiver and are not subscribed to service with a final warning letter. The letter will provide the customer with contact information for both Recology and RWMA to address any concerns and it will provide customers with information on how to comply. Service containers will be delivered by Recology if the customer does not set up compliant service within 30 days of receiving the notice.

RWMA staff have estimated that this notice will be sent to approximately 12% of commercial and multi-family customers. We will begin in areas with the least number of non-compliant accounts and work our way through the RWMA service area with an anticipated completion date of rolling out recycling and organics collection service by the end of 2024.

### ***Monitoring Compliance Through Route Reviews***

In 2023, Recology conducted route reviews on behalf of the RWMA in Yuba County and Live Oak as a courtesy. Route reviews are a visual inspection of randomly selected containers and are to be conducted for both residential and commercial accounts. Although SB 1383 does not quantify how many inspections must be completed, it does require route review inspections be conducted on every route and for every commodity (garbage, recycling, and organics). Route reviews can be delegated to Recology, but will need to be negotiated into the current contract. Alternatively, RWMA can request bids from qualified consultants to provide this service.

### ***Procuring Recovered Organic Waste Products***

To create a more circular economy, SB 1383 requires jurisdictions to procure organic waste products such as compost and mulch. A target is set based on population. RWMA contracted with Zero Foodprint, a direct service provider, to match farms and ranches with compost facilities to procure and use compost.

The contract placed a required on Zero Foodprint to develop and operate a Compost Purchase Rebate Program (“Program”). The program provided rebates of 10 percent on purchases of 30 cubic yards or more of compost from Recology Ostrom Organics. It also included outreach, a dedicated website, rebate agreements, and reporting components, with materials distributed through the Authority and Recology Ostrom Organics. Unfortunately, this resulted in zero participation in 2023. RWMA staff are working with Zero Foodprint to identify gaps and how we can shift to a successful program for 2024 and beyond.

**DRAFT AGREEMENT WITH ZERO FOODPRINT FOR SB 1383 RECOVERED  
ORGANIC PRODUCT PROCUREMENT**

**INTRODUCTION AND BACKGROUND**

Senate Bill 1383 (2016) requires each jurisdiction to meet an annual per capita recovered organic product procurement target which could be sourced from compost; mulch; renewable gas for transportation, electricity, or heat; or electricity from biomass conversion to strengthen the markets and incentivize the development of new and expanded organics processing facilities. Per the amended Regional Waste Management Authority (RWMA) JPA agreement, procurement remains a member jurisdiction responsibility although the RWMA is committed to assisting with a regional approach. To ease jurisdictions into the requirement, Assembly Bill 1985 (2022) reduced the immediate requirement to just 30% for 2023, 65% for 2024, and 100% for 2025.

For 2023 efforts focused on local compost procurement of products that are produced at the local Recology Ostrom Organics facility to control costs and distribute compost locally. RWMA staff and the RWMA member jurisdiction administrators developed a compost purchase rebate program modeled on one that was established in Sonoma County by contracting with Zero FoodPrint (ZFP). ZFP is private non-profit organization that coordinates compost application at agricultural sites on behalf of California municipalities. Although the scope of this program was outside of ZFP’s standard Compost Connector program design ZFP agreed to develop and implement a pilot compost rebate program on behalf of the RWMA and its member agencies. The program was designed to provide a 10% rebate on the purchase price of minimum compost orders of at least 30 cubic yards from Recology Ostrom Organics up to the required number of cubic yards necessary for compliance.

Zero Foodprint reported that the local Recology Ostrom Organics rebate program did not facilitate any compost procurement in 2023. Zero Foodprint was able to provide 605.18

tons of compost procurement credits to RWMA through other compost brokering activities they undertook as part of their Compost Connector Statewide program in Madera and San Diego Counties. Zero Foodprint recommends that RWMA focus on using ZFP's Compost Connector compost broker relationships to satisfy the 2024 and 2025 Recovered Organic Waste Product requirements. Under this program local agricultural users will still have the opportunity to use the compost broker services ZFP provides to acquire compost, but it will not limit participation to Yuba and Sutter counties.

Attached for Board consideration is a draft agreement between the RWMA and ZFP to fully satisfy the SB 1383 Recovered Organic Waste Procurement Requirements by facilitating the application of a maximum 5,449.9 tons of compost in 2024 and 8,384.5 tons of compost in 2025. These services will cost \$21 per ton of compost applied for a cost of \$114,448.15 in 2024 and \$176,074.08 in 2025. All required reporting and documentation will be provided by Zero Foodprint to RWMA staff as evidence of achieving the procurement requirements.

The total cost of the program will be covered by reallocating SB 1383 Local Assistance Grant Funds (OWR4) that were previously dedicated to a food dehydrator pilot program, the outreach plan, recordkeeping software, edible food recovery software and personnel categories.

The draft agreement has been reviewed by Zero Foodprint and RWMA staff.

### **RECOMMENDATION**

Authorize execution of a contract with Zero FoodPrint as proposed.

### **FISCAL IMPACT**

The City will pay ZFP \$21 per ton for compost delivered to farming operations on behalf of the RWMA member agencies. The \$290,522.23 contract will be funded by the City's SB 1383 Local Assistance Grant (OWR4) from the California Department of Resources Recycling and Recovery (CalRecycle).

## Proposal to the Yuba Sutter RWMA for SB1383 Compost Procurement

---

### Overview:

Zero Foodprint is pleased to submit our proposal to the Yuba Sutter RWMA to meet the procurement requirements of the California Senate Bill 1383 (SB1383). Zero Foodprint has the experience and network to oversee compost procurement and use in agriculture throughout California. Our focus on regenerative agriculture means that each ton of compost procured not only avoids short lived climate pollutants, but promotes long term carbon sequestration within the state, supporting the health of our soil, our food, and our population.

Furthermore, Zero Foodprint is uniquely suited to oversee and administer farm projects with detailed compliance and reporting. ZFP has been procuring compost on behalf of jurisdictions for SB1383 since initial pilot projects began in 2021, and currently works with numerous jurisdictions as well as state and federal agencies for farm project management, reporting, compliance, and record keeping.

### Proposal:

Zero Foodprint will provide compost procurement and record keeping for the Yuba Sutter RWMA to assist with its 2024 and 2025 procurement targets of at least 5,449.9 and 8,384.5 tons of compost, respectively. Our pricing for this procurement will be based on your budget and climate goals. Pricing for both years' procurement is offered on a sliding scale ranging from \$290,522.23 to \$539,541.29.

### SB1383 Background:

In September 2016, Governor Edmund Brown Jr. set methane emissions reduction targets for California (SB 1383 Lara, Chapter 395, Statutes of 2016) in a statewide effort to reduce emissions of short-lived climate pollutants (SLCP). Effective January 1, 2022 the law mandates that businesses and governments divert organic waste away from landfills and instead use composting, anaerobic digestion, and other methods to recycle organic waste. As part of this effort, the law requires the procurement of compost that meets certain specifications.

Each Jurisdiction in California is required to procure quantities of Recycled Organic Waste Products (ROWP) based on their population. The per capita procurement target equals 0.08 tons of organic waste per resident per year. The population of Yuba and Sutter counties, including all jurisdictions within those counties, is calculated at

180,696. This equates to a ROWP procurement target of 14,456 tons. Compost, one of four acceptable ROWPs, is valued at the highest equivalent—meaning that .58 tons of compost is considered 1 ton of ROWP. Thus the Yuba Sutter RWMA’s ROWP target can be calculated as 8,384.5 tons of compost. (14,456 tons ROWP multiplied by .58 tons of compost).

CalRecycle provides the following explanation<sup>1</sup>:

“A jurisdiction’s procurement target is calculated by multiplying the per capita procurement target (0.08 tons of organic waste per California resident per year) by the jurisdiction population, as reported by the California Department of Finance (DOF): [Population Estimates for Cities, Counties, and the State](#) [see 14 CCR Section 18993.1(c)]. For more information, visit [Recovered Organic Waste Product Procurement](#).

For the first year of compliance, 2022, jurisdictions’ procurement targets will utilize the January 1, 2021, population estimates reported by the DOF. Jurisdiction procurement targets will be recalculated every five years to reflect population changes. As such, [annual procurement targets](#) for the 2022 compliance year will be in effect from January 1, 2022, through December 31, 2026.”

In September 2022, California passed AB1985, approving adjustments to SB1383, including the targets of ROWP procurement. This Bill provides a step up approach to 100% of procurement targets, by adjusting the targets as follows: 2023, 30% of the procurement targets; 2024, 65%; and 2025 and beyond, 100% of procurement targets.

## About Zero Foodprint:

Zero Foodprint is a California nonprofit organization that works to fight climate change through growing food. In collaboration with food businesses such as restaurants and groceries, farmers, and communities our work builds a more sustainable food system. The organization was founded in 2015 with the goal of reducing the carbon footprint of the food industry.

Since 2020, Zero Foodprint has focused on regenerative and climate smart agriculture as a way to draw down greenhouse gas emissions and increase the health of the food system. Regenerative agriculture is an approach to farming that emphasizes soil health, biodiversity, and ecosystem services, with the aim of enhancing the long-term sustainability and resilience of agricultural systems. In addition, the organization offers technical support to farmers on how to use compost effectively to improve soil health and productivity and promotes the adoption of regenerative agriculture practices more broadly. To date, Zero Foodprint has provided nearly \$3 Million to farms and ranches in California to support the implementation of these practices.

In addition to private sector funding, Zero Foodprint has grants from the California Department of Food and Agriculture, and the US Department of Agriculture, and is on schedule to oversee over \$12M in grants to farms and ranches throughout the US in the next three years.

Composting is an essential component of regenerative agriculture because it helps to rebuild soil organic matter and improve soil health. It is also a cost effective way to sequester CO<sub>2</sub>. This is in addition to the reduction of greenhouse gas emissions that come from diverting organic waste from landfills, where it would otherwise decompose and release methane, a potent greenhouse gas.

By working with local communities and businesses on collective action and funding, Zero Foodprint is helping to build a more sustainable and resilient food system.

Zero Foodprint has provided procurement services to numerous Jurisdictions, completing compost procurement and record keeping on their behalf. Zero Foodprint is in frequent contact with CalRecycle regarding SB1383 and procurement of ROWP. This procurement program has been designed to meet a jurisdiction's needs and CalRecycle's requirements.

Zero Foodprint is also active in the compost industry, including membership in the US Composting Council and holding a board position in the CA Association of Compost Producers.

### Compost Connector:

Zero Foodprint (ZFP) is uniquely positioned to administer the procurement and use of compost in California. With a network of scores of technical experts, agricultural organizations, and hundreds of farms and ranches throughout the state, we have the experience and the expertise to procure compost and utilize it towards long term greenhouse gas drawdown.

In response to SB1383, ZFP created the farmer-facing program Compost Connector. This program matches farms and ranches seeking compost with funding from jurisdictions interested in meeting the procurement targets.

The real world costs of using compost in agriculture are high, and the compost itself can often be the lowest cost. In addition to the material itself, transportation and application contribute significantly to the overall expense. These costs average \$75 to \$100 per ton of compost, once it is hauled to a farm and spread on the crops. Compost Connector reduces these costs for farms and ranches and creates financial opportunities for additional compost use. In many cases, Zero Foodprint contributes its own funds in addition to jurisdiction procurement funds to execute these compost application projects.

In addition to the procurement services, Zero Foodprint maintains all records of the compost transaction and use, providing project level details and reporting. These reports will provide the Yuba Sutter RWMA with simple compliance reporting to CalRecycle. When farms and ranches utilize compost following specific agricultural practice standards, Zero Foodprint is able to model the carbon sequestration utilizing COMET. COMET is a database and modeling tool designed by Colorado State University in partnership with the USDA and California Department of Food and Agriculture. This information can assist the Yuba Sutter RWMA in both its procurement targets and any climate action plans or decarbonization plans through nature based climate solutions. A sample report is attached to this proposal.<sup>2</sup>

### Pricing:

Zero Foodprint is able to offer sliding scale pricing designed to balance budgets and climate goals.

This pricing is offered in a way to allow you to choose what's best for your jurisdiction. You may select all of one price option for your procurement target or, based on your budget and climate goals, divide your procurement amount between the two tiers.

**EXHIBIT A TO SERVICES CONTRACT  
SAMPLE SCOPE OF WORK**

**1. The Work.**

1.1 The purpose of the work to be provided by Zero Foodprint to Yuba Sutter RWMA is to facilitate RWMA’s compliance with Senate Bill (“SB”) 1383’s recovered organic waste product procurement requirements, as described in the California Code of Regulations Title 14, Division 7, Chapter 12, Article 12 – Procurement of Recovered Organic Waste Products (14 CCR 18993.1 et seq.) (“SB 1383 Regulations”).

1.2 Zero Foodprint will use funds provided by RWMA pursuant to section 3, below, to provide reimbursements to incentivize farmers and other compost users (“Farmers”) to acquire and use recovered organic waste product (“compost”) that complies with the requirements of the SB 1383 Regulations.

1.3 Zero Foodprint will require Farmers to use compost only from acceptable sources per SB 1383 Regulations sec. 18993.1(f)(1) and will require that Farmers use the compost in a manner that satisfies the requirements of the SB 1383 Regulations.

1.4 Zero Foodprint will obtain from Farmers necessary documentation to ensure compliance with SB 1383 Regulations and provide that documentation to RWMA.

1.5 Zero Foodprint will ensure that any compost procured on RWMA's behalf is not applied toward the SB 1383 recovered organic waste product procurement target of any other jurisdiction except as authorized by RWMA.

1.6 Zero Foodprint and RWMA agree that the Farmers are intended to be Direct Service Providers to RWMA pursuant to SB 1383 Regulations sec. 18982(17). If Zero Foodprint itself procures the compost on behalf of RWMA, Zero Foodprint shall be the Direct Service Provider to RWMA pursuant to SB 1383 Regulations sec. 18982(17).

**2. Procurement Term.**

Zero Foodprint will work to procure compost on RWMA's behalf from the effective date of this Agreement until XX/XX/XXXX (the “Procurement Term”).

**3. Payment.**

3.1 The total payment by RWMA to Zero Foodprint under this Agreement shall not exceed \$XXX,XXX.

3.2 Payment Schedule

a. Within twenty (20) business days of the effective date of this Agreement, RWMA shall pay to Zero Foodprint [10%] to facilitate initiation of the reimbursement program.



4. **Procurement Goal.**

- a. Agreements between Zero Foodprint and the Farmers;
- b. Name, physical location, and contact information of each entity, operation, or facility from which the compost was procured;
- c. Amount of compost procured;
- d. General description of how the compost was used;
- e. Description of where the compost was applied;
- f. Invoices or receipts for purchase of the compost.

5.2 Zero Foodprint will provide the documentation listed in section 5.1 to [insert RWMA contact to receive documentation] no later than sixty (60) days after the end of the Procurement Term.

5.3 If the California Department of Resources Recycling and Recovery (“CalRecycle”) or other RWMA with oversight over RWMA's compliance with SB 1383 and the SB 1383 Regulations requests from RWMA further documentation to establish procurement and use of the compost, Zero Foodprint will work with RWMA to identify, obtain, and/or provide such documentation.

---

## Compost Requirements

As required in 14 CCR 18993.1(f)(1), compost procured to perform the Services shall meet the following criteria:

- 1) Materials:
  - a) Acceptable materials are:
    - i) Compost, including fine, medium, and coarse compost.
    - ii) The portion of topsoil, biotreatment soil mix, or other blend that is compost.
    - iii) See attached specification for additional requirements.
  - b) Unacceptable materials include:
    - i) Compost that exceeds state maximum limitations for pathogens, metals, and physical contaminants in 14 CCR § 17868.2 – 17868.3.1.
    - ii) Uncomposted compostable materials, including:
      - (1) Digestate
      - (2) Biosolids/sewage sludge
      - (3) Manure
      - (4) Tree trimmings and green waste
    - iii) Biochar
    - iv) Fertilizers and soil amendments, including:
      - (1) synthetic fertilizer
      - (2) nitrolized sawdust
      - (3) gypsum
      - (4) urea
    - v) Topsoil, fill (except as described in (1)(a)(ii))
- 2) Sources:
  - a) Acceptable sources of compost: (per 14 CCR 18993.1(f)(1)):
    - i) A compostable material handling facility with a Full Solid Waste Facility Permit or Registration Permit, or that is authorized under the Enforcement City Notification Tier under 14 CCR § 17854.1
    - ii) A large volume in-vessel digestion facility that composts on-site.
- 3) Definitions:
  - a) “Biochar” means the charcoal product of biomass conversion through pyrolysis (along with ash and syngas).
  - b) “Biosolids” means solid, semi-solid, or liquid residue generated during the treatment of domestic sewage in a treatment works. Biosolids includes, but is not limited to, treated domestic septage and scum or solids removed in primary, secondary, or advanced wastewater treatment processes. Biosolids includes the residue solids resulting from the co-digestion of anaerobically digestible material with sewage sludge. Biosolids does not include ash generated during the firing of sewage

sludge in a sewage sludge incinerator or grit and screenings generated during the preliminary treatment of domestic sewage in a treatment works. 14 CCR 17852(a)(9)

- c) “Compost” means the product resulting from the controlled biological decomposition of organic solid wastes that are source separated from the municipal solid waste stream, or which are separated at a centralized facility. 14 CCR 17896.2(a)(4)

- f) “Digestate” means the solid and/or liquid residual material remaining after organic material has been processed in an in-vessel digester. 14 CCR 17896.2(a)(6)
- g) “Large Volume In-vessel Digestion Facility” means a facility that receives an average greater than 100 tons of solid waste per operating day or greater than 700 tons (2,800 cubic yards) per week of solid waste for digestion in an in-vessel digester. 14 CCR 17896.2(a)(15)
- h) “Manure” is an agricultural material and means accumulated herbivore or avian excrement. This definition shall include feces and urine, and any bedding material, spilled feed, or soil that is mixed with feces or urine. 14 CCR 17896.2(a)(18)

This agreement is made by and between Grower Example (“Provider”) and Zero Foodprint (“ZFP”), who agree as follows:

1. Purpose. Provider wishes to acquire recovered organic waste product for use at Example Farm [business name] in the form of finished compost (“Compost”) on behalf of ZFP’s client agencies (“Agencies”) to assist the Agencies in complying with the requirements of regulations implementing Senate Bill 1383, California Code of Regulations, title 14, sections 18993.1 through 18993.4 (the “SB 1383 Regulations”), in exchange for reimbursement of some of Provider’s costs to acquire the Compost. Provider thus intends to and agrees to be a “Direct Service Provider” as defined by the SB 1383 Regulations, section 18982(17) to the Agency/ies specified in Section 2.c, below.
2. Compost Reimbursement Program
  - a. This Compost Reimbursement Program is subject to ZFP obtaining funding for the program. Signing this agreement does not guarantee that Provider will receive reimbursement for Compost. ZFP may suspend the program at any time, for any reason, including but not limited to lack of or change in funding or change in the SB 1383 Regulations or the interpretation thereof.
  - b. Provider acknowledges that only Compost products that (i) meet the definition of compost in California Code of Regulations, title 14, sections 17896.2(a)(4) and 18993.1(f)(1), and (ii) are obtained from a vendor listed on ZFP’s list of Approved Vendors of Compost (see section 2.e.i, below) are eligible for reimbursement.
  - c. Provider agrees that the Agencies listed in Exhibit A may claim credit for Provider’s use of the Compost.
  - d. Provider agrees that it will not allocate Compost reimbursed pursuant to this Agreement to any other organization or jurisdiction for the purpose of satisfying SB 1383 compost procurement requirements.
  - e. To receive a reimbursement for purchased Compost, Provider must comply with the following steps:
    - i. ZFP will maintain a list of Approved Vendors of Compost, which is available at <https://www.zerofoodprint.org/compost> (the “Portal”). Only Compost purchased from Approved Vendors is eligible for reimbursement.
    - ii. ZFP will post on the Portal when reimbursements are available for purchasing Compost and the value of such reimbursements. To receive a reimbursement, Provider must first start a claim. Once a claim has been

started, Provider must select an available reimbursement by logging in to the “Portal” and selecting quantity and type of reimbursement coupons.

- iii. After claiming an amount of Compost for reimbursement via the Portal, Provider must purchase and request reimbursement for the amount of Compost claimed within 30 days. If Provider does not submit documentation for reimbursement pursuant to Section 2.d.iv, below, by that time, ZFP may release the claimed reimbursement to other program participants, and Provider may not be reimbursed after that time.
- iv. After claiming the Compost, Provider must provide the following documentation to ZFP within 30 days, by logging in to Portal, selecting the previously made claim, and uploading the following documentation:
  1. Invoice(s) for Compost that includes the name and address of Approved Vendor, Compost product name, and amount of Compost product purchased (by weight or volume). The name on the invoice must match the name of the party signing this Agreement or the name of the farm identified in Section 1.
  2. Brief description of how Compost was used.
  3. Identification of location where Compost was used.

**3. ZFP Obligations**

- a. Upon receipt from Provider of the documentation described in Section 2.e.iv, ZFP will review the claim and uploaded documentation. Upon review, satisfactory and complete claims will be approved. Payment will be made via paper check or ACH payment.

**4. General Provisions**

- a. Term. The term of this Agreement shall begin on the date last signed below and end on 12/31/2024.
- b. Public Records. This Agreement and documentation submitted to ZFP pursuant to this Agreement may be provided to Agencies contracting with ZFP, and thereafter may become public records subject to disclosure under the California Public Records Act, Cal. Gov. Code sec. 7290.000, et seq.
- c. Assumption of Risk/Release of Liability. By signing this Agreement, Provider promises not to sue or otherwise make a claim against ZFP or the Agencies (including ZFP’s and the Agencies’ employees, officers, agents, volunteers, subcontractors, successors, and assigns) for any injury, property damage, or other harm related to Provider’s participation in the Compost reimbursement

program, including purchase and use of the Compost, and transportation of the Compost to the location where Provider uses it.

Provider expressly agrees that this assumption and release is intended to be as broad and inclusive as permitted by California law. Provider acknowledges that it has read the foregoing and is aware of the legal consequences of this Agreement including that it prevents it from suing ZFP and the Agencies for any injury or property damage suffered due to participation in the Compost reimbursement program.

- d. Termination. Either Provider or ZFP may cancel this Agreement at any time and without cause upon five (5) days' written notice. In the event of termination, Provider shall be entitled to reimbursement for all Compost claimed and purchased pursuant to Section 2.d prior to the effective date of termination, provided Provider provides ZFP with the documentation required by Section 2.d.iv.
- e. Amendments. The parties may amend this Agreement only by a writing signed by all the parties.
- f. Dispute Resolution. The parties shall make a good faith effort to meet and to settle any dispute or claim arising under this Agreement prior to pursuing litigation. If any litigation is commenced between parties to this Agreement concerning any provision hereof or the rights and duties of any person in relation thereto, each party shall bear its own attorneys' fees and costs.
- g. Governing Law. The laws of the State of California shall govern this Agreement.
- h. Venue. In the event that either party brings any action against the other under this Agreement, the parties agree that trial of such action shall be vested exclusively in the state courts of California in the County of San Francisco or in the United States District Court for the Northern District of California.
- i. Severability. If a court of competent jurisdiction finds or rules that any provision, including but not limited to any clause, term, section, or subsection, of this Agreement is invalid, void, or unenforceable, the provisions of this Agreement not so adjudged shall remain in full force and effect. The invalidity in whole or in part of any provision of this Agreement shall not void or affect the validity of any other provision of this Agreement.
- j. No Implied Waiver of Breach. The waiver of any breach of a specific provision of this Agreement does not constitute a continuing waiver or a waiver of any other breach of that term or any other term of this Agreement. No waiver or modification is valid unless made in writing.

- k. Successors and Assigns. The provisions of this Agreement and all surviving covenants shall inure to the benefit of and shall apply to and bind the successors, heirs, and assigns of the parties.

**REGIONAL WASTE MANAGEMENT AUTHORITY AND ZERO FOODPRINT AGREEMENT  
FOR ZERO FOODPRINT TO DEVELOP AND OPERATE A COMPOST PURCHASE REBATE PROGRAM**

This Agreement is made by and between the Regional Waste Management Authority (“Authority”) on behalf of the Authority’s Member Agencies (Cities of Live Oak, Marysville, Yuba City and Wheatland and Counties of Yuba and Sutter) and Zero Foodprint (“Contractor”), who agree that:

1. Purpose of Agreement. This is an agreement for development and operation of a Compost Purchase Rebate Program (“Program”) by Contractor that can be applied to the Authority’s Member Agencies’ procurement targets for compliance with Senate Bill 1383 regulations (“SB 1383”) as more specifically described in Exhibit A - Scope of Work of this Agreement. Authority will be responsible for allocating the total tons of compost procured through the rebate program to the Authority’s Member Agencies.
2. Term. The term of this agreement commences on the date both parties sign this Agreement (“Effective Date”) and extends through **April 1, 2026**, or the completion of the Program as described in Exhibit A – Scope of Work, whichever occurs first. This agreement may be renewed by mutual written agreement between the parties. Authority may terminate this agreement upon written notice to Contractor for material breach of this agreement.
3. Payment. Authority shall reimburse Contractor \$21.00 per ton of procured compost as described in Exhibit A – Scope of Work. Contractor is not authorized to undertake any efforts or incur any costs whatsoever under the terms of this Agreement until receipt of a copy of this Agreement signed on behalf of the Authority. Authority shall provide Contractor with a ten percent (10%) retainer upon both parties signing this Agreement and the initial invoice may be submitted only after (1) this Agreement is fully executed, (2) insurance certificates and endorsements required by this Agreement have been submitted, and (3) signed Federal Taxpayer ID Number Form (substitute IRS Form W-9) has been submitted. Contractor will invoice not more than once per month, and payments will be due and payable by Authority within 30 days of submittal of the invoice and the supporting documentation described in Exhibit A – Scope of Work is submitted.
4. Compliance With Laws. Contractor shall comply with all applicable federal, state, and local laws, codes, ordinances, regulations, orders, and decrees applicable to this project. Contractor represents and warrants to the Authority that Contractor shall, at its own expense, keep in effect or obtain at all times during the term of this Agreement any licenses, permits, insurance and approvals which are legally required for Contractor to practice its profession or are necessary and incident to the due and lawful prosecution of the services it performs under this Agreement. Contractor shall at all times during the term of this Agreement provide written proof of such licenses, permits, insurance, and approvals upon request by the Authority. The Authority is not responsible or liable for Contractor’s failure to comply with any or all of the requirements contained in this paragraph.

5. Insurance. Contractor and all subcontractors shall procure and maintain insurance as required by the provisions set forth in Exhibit B – Insurance Requirements. Compost purchasers under this Agreement (as described in Exhibit A – Scope of Work) shall not be considered subcontractors for the purposes of this requirement.
6. Independent Contractor. In the performance of the services in this Agreement, Contractor is an independent contractor and is not an agent or employee of the Authority. Contractor, its officers, employees, agents, and subcontractors, if any, shall have no power to bind or commit Authority to any decision or course of action, and shall not represent to any person or business that they have such power. Contractor has and shall retain the right to exercise full control of the supervision of the services and over the employment, direction, compensation, and discharge of all persons assisting Contractor in performance of said service hereunder. Contractor shall be solely responsible for all matters relating to the payment of its employees, including compliance with social security and income tax withholding, workers' compensation insurance, and all other regulations governing such matters.
7. INDEMNITY. Contractor agrees to indemnify, defend, and hold harmless the Authority, the Authority's member jurisdictions, and their respective officials, officers, members, agents, employees and volunteers (collectively the "indemnitees") from and against any and all actions, claims, demands, losses, and costs, (collectively "Losses") arising out of or in any way connected with the performance of this agreement. Contractor shall pay all costs and expenses that may be incurred by the Indemnitees in enforcing this indemnity, including reasonable attorneys' fees. The duty to defend Indemnitees from the Losses is a separate obligation from the obligation to indemnify. The duty to defend arises immediately upon notice of a claim and continues until such claim is finally resolved. The duty to defend applies even if the claim is meritless. The duty to defend applies even if it is claimed that the Indemnitees are responsible for the alleged Losses. The provisions of this section survive the expiration or earlier termination of the agreement.
8. Assignment; Subcontracting; Employees.
  - a. Assignment. Contractor shall not assign, delegate, or transfer its duties, responsibilities, or interest in this Agreement without the prior express written consent of the Authority. Any assignment without such approval shall be void and, at the Authority's option, shall terminate this Agreement and any license or privilege granted herein.
  - b. Subcontracting. Contractor shall not subcontract or otherwise assign any portion of the work to be performed under this Agreement without the prior express written consent of the Authority. If the Authority consents to Contractor's hiring of subcontractors, all subcontractors are deemed to be employees of Contractor and Contractor agrees to be responsible for their performance. Contractor shall give its personal attention to the fulfillment of the provisions of this Agreement by all of its employees and subcontractors, if any, and shall keep the work under its control.

- 9. Exhibits. All exhibits referred to in this Agreement are attached hereto and are by this reference incorporated herein and made a part of this Agreement.
- 10. Contract Administration. For purposes of notice to either party, the primary representatives of Authority and Contractor for contract administration are listed below.

**Exhibit A - Scope of Work****1. The Work**

- 1.1. The purpose of the work to be provided by Contractor to Authority is to facilitate the Authority Member Agencies' compliance with SB 1383 recovered organic waste product procurement requirements, as described in the California Code of Regulations Title 14, Division 7, Chapter 12, Article 12 – Procurement of Recovered Organic Waste Products (14 CCR 18993.1 et seq.). Contractor shall perform these Services on behalf of the Authority and its Member Agencies.
- 1.2. Contractor will use funds provided by Authority pursuant to section 3 below, to provide reimbursements to incentivize farmers and other compost users ("Farmers") to acquire and use recovered organic waste product ("compost") that complies with the requirements of SB 1383 Regulations.
- 1.3. Contractor will require Farmers to use compost only from acceptable sources per SB 1383 Regulations sec. 18993,1 (f)(1) and will require that Farmers use the compost in a manner that satisfies the requirements of the SB 1383 Regulations.
- 1.4. Contractor will obtain from Farmers necessary documentation to ensure compliance with SB 1383 Regulations and provide that documentation to Authority.
- 1.5. Contractor will ensure that any compost procured on Authority's behalf is not applied toward the SB 1383 recovered organic waste product procurement target of any other jurisdiction except as authorized by Authority.
- 1.6. Contractor and Authority agree that the Farmers are intended to be Director Service Providers to Authority pursuant to SB 1383 Regulations sec. 18982(17). If Contractor itself procures the compost on behalf of Authority, Contractor shall be the Director Service Provider to Authority pursuant to SB 1383 Regulations sec. 18982(17).

**2. Procurement Term**

- 2.1. Contractor will work to procure compost on Authority's behalf from the effective date of this Agreement until 04/01/2026 (the "Procurement Term").

**3. Payment.**

- 3.1. Contract Amount. Authority agrees to pay up to \$21.00 per ton of procured compost. Authority agrees to pay Contractor a sum not to exceed \$290,500.00 for services to be performed and reimbursable costs incurred under this Agreement.
- 3.2. Payment Schedule. Within thirty (30) days of the effective date of this Agreement, Authority shall pay Contractor a ten percent (10%) retainer to facilitate initiation of the reimbursement program.

**4. Procurement Goal.**

- 4.1. Contractor will ensure that 13,834.4 tons or the equivalent or more compost is procured on Authority's behalf, including 5,449.9 tons of compost purchased and delivered to Farmers before December 31, 2024, and 8,384.5 tons of compost purchased and delivered between January 1 and December 31, 2025.
- 4.2. Authority shall not compensate Contractor for compost purchased and delivered to Farmers in excess of 5,449.9 tons before December 31, 2024, and 8,384.5 tons purchased and delivered between January 1 and December 31, 2025.

**5. Documentation Provided to Authority.**

- 5.1. Contractor shall provide Authority the following documentation to verify procurement of compost by the Farmers on Authority's behalf, in accordance with SB 1383 Regulations sec. 18993.2:
  1. Agreements between Contractor and the Farmers;
  2. Name, physical location, and contact information of each entity, operation, or facility from which the compost was procured;
  3. Amount of compost procured;
  4. General description of how the compost was used;
  5. Description of where the compost was applied; and
  6. Invoices or receipts for purchase of the compost.
- 5.2. On an annual basis during the term of this Agreement, the Contractor shall provide the documentation listed in section 5.1 to the Authority's Executive Director, or his or her designee, no later than June 30.
- 5.3. If the California Department of Resources Recycling and Recovery ("CalRecycle") or other Authority with oversight over Authority's compliance with SB 1383 and the SB 1383 Regulations requests from Authority further documentation to establish procurement and use of the compost, Contractor shall work with Authority to identify, obtain, and/or provide such documentation.

**Exhibit B – Insurance Requirements**

1. During the life of this Agreement, Contractor and all subcontractors shall maintain the following minimum insurance:
  - A. Comprehensive general liability insurance: Insurance Services on an “occurrence” basis including products and completed operations, personal & advertising injury liability, blanket contractual liability, and broad-form property damage liability coverage. The combined single limit for bodily injury and property damage shall be at least \$2,000,000. If a general aggregate limit applies, either the general aggregate limit shall apply separately to this project/location or the general aggregate limit shall be twice the required occurrence limit.
  - B. Statutory workers' compensation and employer's liability insurance as required by state law with a limit of at least \$1,000,000 per accident for bodily injury or disease. Neither Contractor nor its carrier shall be entitled to recover any costs, settlements, or expenses of workers' compensation claims arising out of this agreement. The Employer's Liability policy shall be endorsed to waive any right of subrogation against the Authority, its employees or agents.
  - C. Contractor shall submit to Authority certificates of insurance and endorsements for the policies listed above. All endorsements shall be signed by a person authorized by that insurer to bind coverage on its behalf. Authority has the right to require Contractor's insurer to provide complete, certified copies of all required insurance policies. Contractor shall not cancel, assign, or change any policy of insurance required by this agreement or engage in any act or omission that will cause its insurer to cancel any insurance policy required by this Agreement except after providing 30 days prior written notice to Authority. If an insurance policy required by this Agreement is unilaterally cancelled or changed by the insurer, the Contractor shall immediately provide written notice to the Authority and obtain substitute insurance meeting the requirements of this Agreement. Nothing in this subsection relieves Contractor of its obligation to maintain all insurance required by this Contract at all times during the term of the Agreement.
2. As to all of the policies of insurance listed above, the following shall apply:
  - A. Authority as Additional Insured. The Authority, the Authority's member jurisdictions, and their officers, officials, employees, agents and volunteers are to be covered as insureds with the same coverage and limits available to the named insured regarding: liability arising out of activities performed by or on behalf of the Contractor; premises owned, occupied or used by the Contractor, or automobiles owned, leased, hired or borrowed by the Contractor. The coverage shall contain no special limitations on the scope of the protection afforded to the Authority, its officers, officials, employees, agents or volunteers. Any available insurance proceeds broader than or in excess of the

specified minimum Insurance coverage requirements and/or limits shall be available to the Additional Insured. Any available insurance proceeds broader than or in excess of the specified minimum Insurance coverage requirements and/or limits shall be available to the Additional Insured; the additional insured coverage and limits shall be (1) the minimum coverage and limits specified in this Agreement; or (2) the broader coverage and maximum limits of coverage of any Insurance policy or proceeds available to the named Insured; whichever is greater. For any claims related to this project, the Contractor's insurance coverage shall be primary insurance as respects the Authority, its officers, officials, employees, and volunteers. Any insurance or self-insurance maintained by the Authority, the Authority's member jurisdictions, and their officers, officials, employees, or volunteers shall be excess of the Contractor's insurance and shall not contribute with it. Coverage can be provided in the form of an endorsement to the Contractor's insurance, or as a separate owner's policy, or on the Authority's own form.

- B. Other Insurance Provisions. The policies are to contain, or be endorsed to contain, the following provisions:
- i. Any failure to comply with reporting provisions of the policies shall not affect coverage provided to the Authority, the Authority's member jurisdictions, and their officers, officials, employees or volunteers.
  - ii. The Contractor's insurance shall apply separately to each insured against whom claim is made or suit is brought, except with respect to the limits of the insurer's liability.
- C. Umbrella/Excess Insurance. The limits of insurance required in this agreement may be satisfied by a combination of primary and umbrella or excess insurance. Any umbrella or excess insurance shall contain or be endorsed to contain a provision that such coverage shall also apply on a primary and non-contributory basis for the benefit of Authority (if agreed to in a written contract or agreement) before the Authority's own Insurance or self-insurance shall be called upon to protect it as a named insured.
3. If a death, serious personal injury or substantial property damage occurs in connection with the performance of this Agreement, Contractor shall immediately notify Authority by telephone. Contractor shall promptly submit to Authority a written report, in such form as may be required by Authority of all accidents which occur in connection with this Agreement. This report must include the following information: (1) name and address of the injured or deceased person(s); (2) names and address of Contractor's subcontractor, if any; (3) name and address of Contractor's liability insurance carrier; and (4) a detailed description of accident and whether any of Authority's equipment, tools, materials or staff were involved. Failure to comply with this section shall constitute a material breach of this agreement.

# Procurement

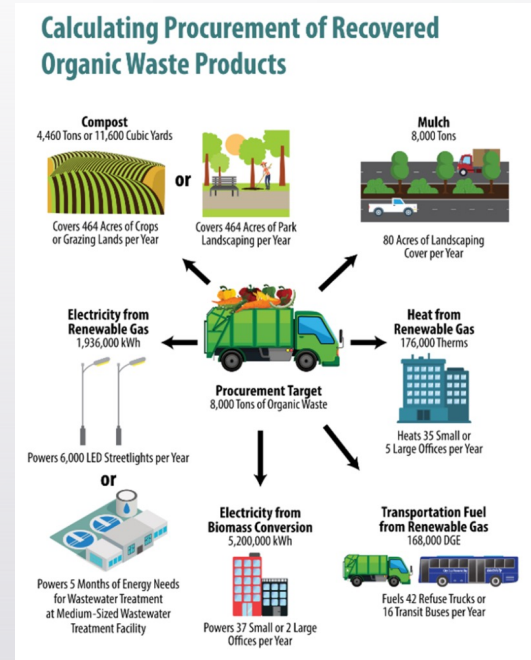


- Purpose of Procurement:
  - Require jurisdictions to procure recovered organic waste products to strengthen markets for the products, to drive infrastructure investment, and create a more circular economy for organic waste.
- Procurement of Recovered Organic Waste Products:
  - Jurisdictions are required to procure products made from recovered organic waste, of which **compost** is the most available and cost-effective.
- Procurement Reporting:
  - Entities report to CalRecycle each August 1<sup>st</sup> on procurement activities conducted in the prior year.



# What is a Procurement Target

- Each jurisdiction's procurement target is calculated based on their 2021 Population (recalculated in 2027)
- AB1985 was passed in September of 2022 which reduced the procurement targets for 2023 to 30% of the ROWP target and for 2024 to 65% of the ROWP target.
- The target may be met by purchasing Compost, Mulch, Renewable Energy (Transportation Fuel, Heat, and Electricity) from Anaerobic Digestion and/or Electricity from Biomass Conversion.
  - Compost is the most widely available and cost-effective way to meet the requirement
  - Compost brokers further lower the cost of compost application by mitigating the costs of transportation and spreading of material.



# RWMA's Procurement Target

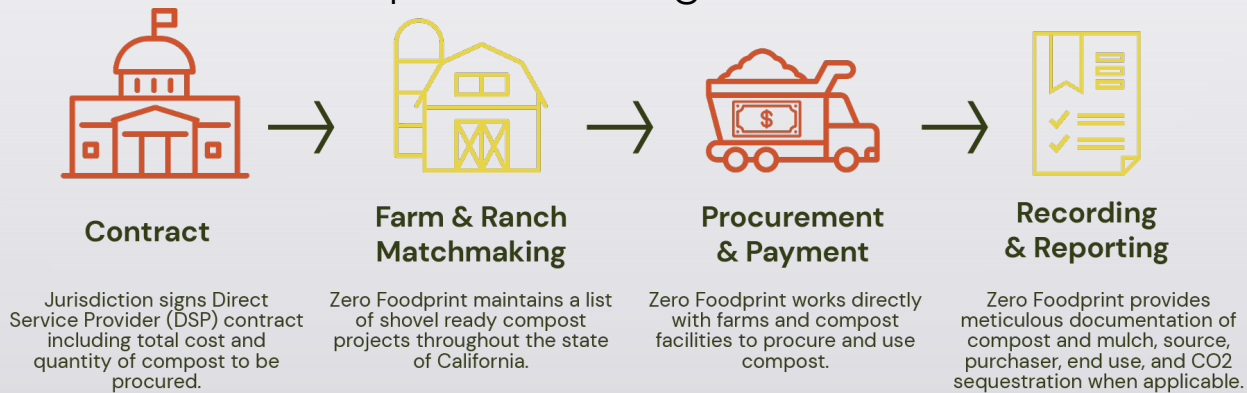
- The RWMA with all its Jurisdictions has a procurement target of **14,456 Tons**
- RWMA Reported 1,045 tons (7.2% of full requirement) of ROWP procurement in 2023.

# How do we meet the Procurement Target

- Direct Service Provider Agreements:
  - These are contracts between jurisdictions and service providers, that aim to facilitate compliance with SB 1383 procurement by ensuring services like composting, mulching, are provided efficiently and effectively.
- Direct Service Agreements can help jurisdictions meet their procurement targets by allowing the services and products provided under the agreement (e.g., compost, mulch) to count towards their procurement goals.



# Zero Foodprint 2023 Agreement

- An agreement was made with ZFP in January 2023 to develop and operate a Compost Purchase Rebate Program.
- Provided 10% rebates on purchases of 30 cubic yards or more of compost from Recology Ostrom Organics.
- Included outreach, a dedicated website, rebate agreements, and reporting components, with materials distributed through the Authority and Recology Ostrom Organics.
  - Lack of program promotion resulted in no rebates in 2023
  - ZFP facilitated 1,046 tons of recovered organic waste for RWMA through its Compost Connector Program.

# 2024 Zero Foodprint Agreement

- In June of 2024, the RWMA began establishing a new agreement with ZFP to assist with its 2024 and 2025 Procurement Targets.
- **What's the difference between this agreement and the last one?**
  - ZFP's Compost Connector Program matches farms and ranches seeking compost with funding from jurisdictions interested in meeting the procurement targets.
  - The Compost Connector Program will be used throughout California, and the compost does NOT need to be purchased directly from the Recology Ostrom Facility.
    - The Program is still available to local agricultural partners, but removing that limitation will allow ZFP to facilitate compost applications Statewide to be able meet RWMA's requirements
  - ZFP will ensure that any compost procured on RWMA's behalf is applied toward the procurement target for our member Jurisdictions.



# 2024 Zero Foodprint Agreement

- Pricing for 2024 and 2025 procurement is estimated at \$290,522
- RWMA Procurement targets are 5,449.9 tons of compost in 2024 and 8,384.5 tons of compost in 2025.
- RWMA prepared a budget revision for the SB 1383 Local Assistance Grant Program (OWR4: 2022-23) to reallocate funds for this agreement.

# Assembly Bill 2346 - Procurement Moving Forward



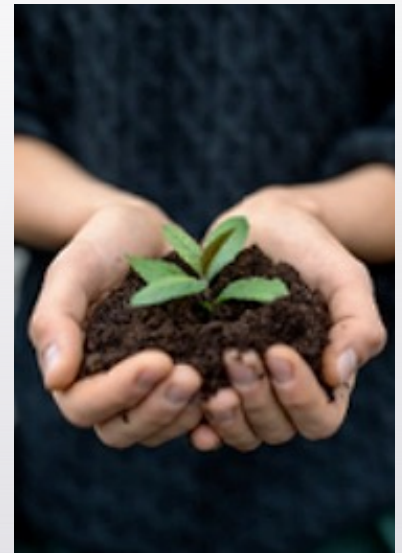
- The proposed legislation, AB 2346 is designed to support the implementation of SB 1383 by allowing additional organic waste products to meet the requirement.
  - This includes expanding the types of compost, mulch, and other derived products that qualify.
- A new procurement credit factor will be created to decrease the SB 1383 organic waste conversion factor for locally applied compost,
  - Giving it nearly five times the procurement credit value compared to other compost.
- Local jurisdictions will be able to set their own per capita procurement targets by using waste characterization data from the last 5 years.



## RWMA and ZFP Conclusion



- In 2023 Procurement target was not met, even with the help of ZFP due to lack of promotion and participation.
- RWMA and ZFP have developed a new Agreement to use the ZFP Compost Connector Program to match agricultural partners seeking compost with funding from the RWMA to meet the procurement targets of SB1383.
  - Compost Connector will allow for local agricultural partners to still acquire discounted compost, but the program will also be available to agricultural users throughout California to fully meet the 2024 procurement target.
- RWMA and its Member Agencies may develop letters of support for AB2346 which may reduce the RWMA's burden with procurement requirements of SB1383.
  - Expands the eligible organic waste products list, incentivizes local programs and facilities to engage in organic waste recycling and procurement, and allows jurisdiction to set their per capita procurement targets.

**HOUSEHOLD HAZARDOUS WASTE GRANT PROGRAM  
(HD 43 CYCLE, FY 2024/2025)**

**INTRODUCTION AND BACKGROUND**

The California Department of Resources Recycling and Recovery (CalRecycle) issued a Notice of Funding Availability for the 43<sup>rd</sup> Cycle of the Household Hazardous Waste (HHW) Grant Program for FY 2023/2024 and applications were due by August 20, 2024. Staff is now requesting that the Board adopt the attached resolution authorizing the submittal of this regional funding application. CalRecycle is proposing to make \$1,000,000 available in this competitive grant cycle for small projects that complement existing and/or regional HHW programs. Examples of small projects eligible for funding include public education and outreach, temporary HHW collection events, minor improvements to an existing HHW facility, purchase of personal protection equipment; and, 8-hour refresher Hazardous Waste Operations and Emergency Response Standards (HAZWOPER) training.

The maximum grant award for regional, rural and JPA applicants is \$100,000. Grant awards are anticipated in early 2025 with the grant term until February 29, 2028. The RWMA applied for and was awarded \$100,000 grant from the 37<sup>th</sup> Cycle of this program which was used to update and print hazardous waste program brochures, install a new outdoor water supply on the east side of the HHW Facility building, purchase replacement and additional personal protection equipment for use at the HHW Facility, and replace portions of cacked concrete paving on the west side of the HHW Facility building.

Due to the application due date and the Board meeting schedule, staff submitted an application for \$100,000 for the 43<sup>rd</sup> Cycle of the HHW Grant Program on August 20, 2024 for the following projects:

- Redesign and print hazardous waste program brochures to update and replace the current brochure stock;
- Purchase replacement and additional personal protection equipment (e.g., gloves, masks and lab coats) for use at the HHW Facility;
- Repair security fencing around the perimeter of the HHW Facility;
- Repair leaks in ceiling of office area at HHW Facility; and
- Replace worn signage promoting E-waste section, re-use items center, and at main entrance of HHW Facility;
- Replace portions of cracked concrete paving on the west side of the building near drop off location; and
- Provide grant project management and administration.

Staff is requesting that the Board adopt the attached resolution authorizing the submittal of a regional application for the 43<sup>rd</sup> Cycle Household Hazardous Waste Grant Program for FY 2024/2025, which is due by the secondary submittal date of September 20, 2024.

**BEVERAGE CONTAINER RECYCLING GRANT PROGRAM  
(RBC CYCLE 36, FY 2024/2025)**

**INTRODUCTION AND BACKGROUND**

The California Department of Resources Recycling and Recovery (CalRecycle) issued a Notice of Funding Availability for the 36th and 37th Cycle of the Beverage Container Recycling (RBC) Grant Program for FY 2024/2025 and applications are due by September 24, 2024. Staff is now requesting that the Board adopt the attached resolution authorizing the submittal of this regional funding application. CalRecycle is proposing to make \$1,500,000 available in this competitive grant cycle for projects that implement new program or enhance existing programs to convenient beverage container recycling opportunities in various locations statewide.

The maximum grant award for regional, rural and JPA applicants is \$275,000. Grant awards are anticipated in early 2025 with the grant term until April 1, 2027 (RBC36 FY 2024-25).

RWMA staff plan to submit an application for \$275,000 for the 36<sup>th</sup> Cycle of the RCB Grant Program on September 24, 2024 for the following projects:

- Water bottle refill stations, including replacements and maintenance;
- Purchase of equipment or materials related to infrastructure (beverage container recycling bins/receptacles, cluster bins, lids, receptacle liners, in-unit totes);
- Dual bin collection systems that are permanently attached together to include landfill and cash redemption value (CRV) collection at bus stops; and
- Public education and outreach materials promoting beverage container recycling.

Staff is requesting that the Board adopt the attached resolution authorizing the submittal of a regional application for the 36<sup>th</sup> Cycle Beverage Container Recycling Grant Program for FY 2024/2025, which is due by the secondary submittal date of October 23, 2024. Letters of authorization for the RWMA to participate in this grant program are not required because the grant will be submitted under the JPA.

**RECOMMENDATION**

**NOW, THEREFORE, BE IT RESOLVED** that the Regional Waste Management Authority is authorized to submit a Beverage Container Recycling Grant Program (RBC36: 2024/2025) regional application, on behalf of itself as Lead Agency and the following participants: Cities of Live Oak, Marysville, Wheatland and Yuba City and the Counties of Yuba and Sutter; and

**BE IT FURTHER RESOLVED** that the Regional Waste Management Authority Executive Director, or his/her designee, is hereby authorized as Signature Authority to execute all documents necessary to implement and secure payment under the Beverage Container Recycling Grant Program; and

**BE IT FURTHER RESOLVED** that this Resolution is effective until May 1, 2027.
